Reserch on Classification of Productive Skill (1)

- Occupational Abilities and Skills in the Car Manufacturing Industry -

Kazuo MORI Yasuyuki KIKUCHI

Productive skill was examined through a survey, which was conducted at a productive site under technological innovation. A trend was also arranged. In August 1991, the questionaire method survey was conducted on skilled workers in a car manufacturing company. The number of valid answers is 1215. The survey included 133 items in the following three areas.

- (1) nature of productive skill: 40 items
- (2) human functions and vocational ability necessary for work: 60 items
- (3) work conditions: 33 items

The summary of the results is shown below. Automation, increased efficiency of the process, etc. were generated by technological innovation. From this, it is clean that the following functions and abilities for the worker are demanded. They are the sensuous function, the high-level skill, judgment, and analysis abilities. In the sensory-motor mechanism, inclination is especially made to delicate feeling and intuition, and visual information processing. High-level skill is inclined to create high accuracy and its related skill and the intellectual management mechanism is inclined to the judgment and the analysis processing. All skilled workers commonly request the productive control contents. Moreover, it can be said that the degree of importance differs according to a skilled worker for individual machine operation.

Thus, the nature of the product manufactured by the factory and the realities of the skill by which work is reflected are now clarified. The change of various equipment through technological innovation will make the following content indispensable; sharpening sensuous function, highly-skilled level, enhancement of judgment and analysis ability, and promotion of work and process improvement. In the future these situations are expected to advance more clearly and widely in a productive post.

The Actual Situation and Ploblem of the General Education Course in Polytechnic Colleges

It is necessary to examine the curriculum by which the graduate image of each department is shown concretely enough so that a polytechnic colleges may obtain the evaluation from the society.

Each department has piled up the improvement for that. A special subject has been enhanced. However, the rate occupied to the whole of the curriculum does not affect very much about the general education course. There is a dislike which has been made negligent a little.

This report examines the role of the general education course in polytechnic colleges and problem. Therefore, analyzed the actual situation of the general education course of 23 polytechnic colleges being established now.

Human Studies in the Care-Service Course

This is a report and study of Human Studies taught in the Care-Service Course, which is founded in Job-Training Schools supervised by the Ministry of Labor. Today, with the coming "old people age", the neccessity of caring for old people is widely noticed. Yet it is not properly understood in our society what the caring is. In this treatise we analyse the consciousness of the students who intend to be care-workers. We consider what kind of troubles or difficulties they have, and point out the tasks of the Human Studies for caring. These are, primarily, to give them proper comprehension of caring, including what caring is to the human being. Secondary, to understand old age and death: to make out how we can get along with them. And thirdly, to attain a deeper conception about the human nature. Above all, we explain what the caring is in detail and from this point of view propose the neccessary elements of the Human Studies for caring.
